# collaboration is the key

In 2022, **Kingston and Merton Chamber of Commerce** worked with Kingston and Roehampton University on a South London Partnership /BIG project, exploring sustainable steps that Chambers can develop for growth.

This was a unique project and pulled together local Chambers of Commerce, local authorities and local BIDs to review best models for Chamber business engagement. The results of this research provided practical recommendations that we can integrate into our future objectives. One key initiative was to create a South London Chambers MOU which will provide a unity of purpose for future funding, bids or investment agreements.

In 2022, we continued hosting and working with Kingston Council on the **THINK GREEN** webinars. This programme talks to business owners who are looking at sustainable processes in their work. We have explored areas such as groceries, green marketing, transport and accreditations. They have been fascinating to facilitate.

The Chamber also worked with the Council to create the new **Kingston Green Business Community**. This is a free-to-join community of Kingston-based businesses of all sizes, sectors, from well-established to start ups. The main aim to share knowledge, skills and bring together people driven to make a stronger environmental impact. It has been encouraging to see so many Chamber members actively contributing and being keen advocates for the green agenda.
